RETREAT 2008

To assist you in arriving at a decision regarding your attendance at "The Retreat" which will be held at the Lakeview Resort and Conference Centre in Gimli on November 7th and 8th, it might be useful to consider the comments made by the brethren who attended the Master Mason Degree Workshop, which was conducted on February 23rd.

The topics presented went well beyond the usual borders of discussion. They were very deep, well researched, informative and educational. There were ample opportunities for discussion and the sharing of personal interpretations of the symbolism. Brethren left feeling enlightened, enthusiastic about future opportunities for learning and prepared to promote future workshops. This comment was made on our website following the workshop: "This is an example of the absolute best of what Freemasonry has to offer!"

Bro Stephen Dafoe was the keynote speaker at a Conference of the Four Western Jurisdictions a few years ago in Canmore. His presentation was entitled *"Awaken my Soul"* and this will be the theme of this year's Retreat. Under his leadership and the experience we have gained by conducting this year's three Degree workshops we envision a session which will have every one of the attendees echoing these comments.

Constitutional Amendments To Be Presented At The 2008 Grand Lodge Communication

Section C-5: Officers of Grand Lodge - Part 1-7 add :

Incorporate new Officers as follows :Very Worshipful Grand Sword Bearer and Very Worshipful Grand Standard Bearer

New Section C-40 - Grand Sword Bearer

The Grand Sword Bearer shall attend all Communications of Grand Lodge and shall perform the duties prescribed for him by the Grand Master. He shall precede in procession of any of the Grand Lodge processions. His rank shall be that of Very Worshipful Brother and be appointed by the incoming Grand Master yearly.

New Section C-41 - Very Worshipful Grand Standard Bearer

The Grand Standard Bearer shall attend all Communications of Grand Lodge and shall perform the duties prescribed for him by the Grand Master. He shall follow the Grand Sword Bearer in procession of any of the Grand Lodge processions. His rank shall be that of Very Worshipful Brother and be appointed by the incoming Grand Master yearly.

Renumber present Sections as required

C-207 Replace C-207 with the following;

The Board shall be the administrative and executive body of the Grand Lodge and without limiting the generality thereof, it shall directly, or by delegation, exercise the powers and perform the duties herein set forth, namely:

a) Conduct the business and affairs of the Grand Lodge of Manitoba and submit to each Annual Communication, a report of it's activities for ratification.

b) Develop an ongoing five year strategic plan and ensure that various committees work diligently to achieve these stated goals and objectives.

(c) To establish special committees for particular purposes, to appoint the members thereof who, except for the chairman, may include individuals who are not Freemasons, and to require such committees to report to the Board.

(d) To inspect or empower any committee under its direction, to inspect all the books, records, and accounts of Grand Lodge and of any constituent Lodge and to summon the attendance before it of any officer of Grand Lodge and of any constituent Lodge; to recommend to the Grand Master that the Charter or dispensation of a Lodge be arrested or that any officer of Grand Lodge or of any constituent Lodge be suspended from office and to report thereon to Grand Lodge.

(e) To control and direct the executive office of Grand Lodge and to appoint an Executive Secretary if the Board deems it expedient to do so, which Executive Secretary shall hold office at the pleasure of the Board.

f) To consider in each year the budgets of receipts and expenditures of the General Fund as prepared by the Committee on Finance and Administration and of the Reserve Fund as prepared by the sub-Committees on Benevolence and on Masonic Enhancement with power to add, delete from, or otherwise vary any part thereof and to approve these budgets prior to presentation to Grand Lodge for final approval.

(g) To control the furniture and regalia of Grand Lodge.

(h) To control all other property belonging to Grand Lodge, to authorize any expenditures it may deem proper for the due administration of the affairs of Grand Lodge and to invest the funds of Grand Lodge in such investments and securities as from time to time are authorized by the Act of Incorporation of Grand Lodge.

(i) To give precedence in the order of business at its meetings to all matters referred to it by the Grand Master or by Grand Lodge.

(j) To approve the form and prescribe the use of petitions for initiation or affiliation and any other forms for use by Lodges or by Grand Lodge as it may deem proper.

(k) To make a recommendation to the Grand Master upon every petition for dispensation to form a new Lodge and to Grand Lodge upon every petition for a Charter.
